Objective

Who were the children of Robert Daugherty and Sarah Taylor? Robert Daugherty signed a marriage bond on 18 November 1784 in Craven County, North Carolina for his marriage to Sarah Taylor. Robert and Sarah were probably born about 1749-1769, and Robert died before 8 November 1843 in Warren County, Kentucky when he was listed as deceased in his estate appraisal.

Limitations: 30 hours were allotted for the research and writing portions of this project

Starting Point Information

Prior to this research, the following information was known:

- Robert Daugherty was the son of Owen Daugherty and his wife Mary of Craven County, North Carolina.¹ A deed created by Owen Daugherty in 1767 named his five children with his first wife: Owen, Richard, Suzanna, Elizabeth and Sarah.² Owen Daugherty's 1785 will mentioned five children with second wife Mary: Robert, Daniel, Ephraim, Rubin, and Hollan[d].
- Robert Daugherty signed a marriage bond that he intended to marry Sarah Taylor on 18 November 1784 in Craven County, North Carolina.³
- Robert Doherty gave consent for his daughter, Mary Doherty, to marry Jacob Romans in a bond on 23 September 1811 in Warren County, Kentucky.⁴
- On 8 November 1843, the property of Robert Daughety, deceased, was appraised by S. Clawson Neighbours, He[dgekoock?] Mcginnis, and Philip C. Romans.⁵
- The appraisal included hoes, plows, furniture, "2 Books, 1 Buck Theological Dic[tionary]," various farm animals, and furniture. Next to the "Buck Theological Dic[tionary]" line item is an illegible phrase that could possibly read "minister [of] the county."
- Online trees and books have claimed that Robert Daugherty was a minister.⁶
- When Robert Daugherty died before 8 November 1843, he left an unnamed widow behind who purchased from his estate.⁷

Peter Daughety administered the estate of Robert Daugherty.⁸

Background Information

In Warren County, Kentucky, census records exist for 1810-1840. The 1800 Federal U.S. Census for Kentucky was lost. An 1864 fire in the courthouse destroyed some records in Warren County, Kentucky, but not all.⁹ Many marriage records remain. Warren County and Butler County, Kentucky border each other. They are located in the south central part of Kentucky. Records for the Daugherty family were found in both counties.

Findings and Correlation

Daugherty Widow

Court records were searched in order to locate additional records about Robert Daugherty's estate and see if his widow was named. An unsourced *FindaGrave* memorial for Sarah (Taylor) Daugherty states that she died

in 1828.¹¹ It's possible that the widow of Robet Daugherty mentioned in the list of those who purchased from his estate was a second wife.¹²

The Warren County Court order book H contains an order on 23 October 1843 about the Robert Daugherty estate, showing his widow was Sarah Daugherty, mother of Peter Daugherty.¹³

Sarah Daughety widow & relict of Robt Daughety decd consenting in writing that Peter Daughety her son may administer on the estate of her deceased husband, whereupon on motion of the said Peter Daughety who having taken the oath required by law the administration of the estate of Robert Daughety decd is granted unto him he having executed bond in the penalty of #1200 with William V. Loving and Thomas b. Wright his securities conditioned as the law directs.

The entry in the court order book was dated 23 October 1843, indicating that Robert Daugherty was deceased before then. Robert Daugherty died intestate and his son, Peter, was appointed to administer his estate. The widow of Robert Daugherty was Sarah Daugherty, almost certainly the same woman he intended to marry in the 1784 Craven County, North Carolina marriage bond. The administrator of Robert's estate was Peter Daugherty, Sarah's son. This indicates that Sarah Daugherty was not a second wife of Robert Daugherty, but the first wife who was the mother of his son, Peter Daugherty, who was old enough to administer an estate in 1843. If he was at least 14 in 1843, Peter was born before 1829.

Peter Daugherty

The 1850 census would show Peter Daugherty's age and give evidence for his birth date. The census was searched and a record was found for Peter in Butler County, Kentucky, age 51.¹⁴ His calculated birth year is 1799. No other men of the same name were found in Kentucky in the 1850 census.

If Peter Daugherty was born in 1799 and was the son of Robert's widow Sarah Daugherty, then Sarah was the same woman Robert Daugherty was married to in 1799. This is indirect evidence that Sarah (Taylor) Daugherty did not die in 1828. The unsourced *FindaGrave* memorial that states Sarah died in 1828 is not accurate.¹⁵

1790 Federal Census

In 1790, Robert Daugherty resided in Craven County, North Carolina.¹⁶ His household included a male over 16 years, a male under 16 years, and two females. His neighbors included Daniel Doherty, probably his brother.¹⁷ Other neighbors included John Fannin, Richard Gilstrap, and William Buchanan.

In Robert's household, the male over 16 was Robert, but the male under 16 is unknown. Robert's son Peter was not born until 1799, so it's likely an unknown son, relative, or laborer. One of the females is almost certainly Robert's wife Sarah and the other female is probably Robert and Sarah's oldest daughter. Daniel had a household of 3 males and 2 females, with two slaves.¹⁸

1800 Federal Census

Robert Daugherty was not found in the 1800 Craven County, North Carolina U.S. Federal Census.¹⁹ The only Daugherty heads of household in Craven County were listed with their surname spelled Dority, including Wilis, Elisabeth, Richard, Owen, Ephraim, and William. Richard, Owen, and Elizabeth could be Robert's half-siblings, and Ephraim is probably his younger brother.

Robert's absence from the 1800 census in Craven County is consistent with three deeds in March 1797 showing Robert sold land in Craven County. He probably left Craven County soon after.

- 1. Robert sold Ephraim Daugherty one hundred acres of land where "Mary Daughety (Mother of said Robert & Ephraim)" lived.²⁰ Robert excepted the graveyard on the property for himself.
- 2. Robert sold "Ephraim Daugehty" fifty acres of land on 2 March 1797.²¹
- 3. Robert sold John Gooding 60 acres of land on 2 March 1797.²²

The first deed confirms that the Ephraim in the 1800 census was his younger brother. Robert and his family migrated to Warren County, Kentucky sometime after 1797. No federal census records exist for Kentucky in 1800. The gap in census records for the Daugherty family from 1790-1810 makes it difficult to analyze their number of children and ages through the years. The bulk of their children were probably born before 1810, which is when we find them on the next census. Future research should examine land and tax records for Robert Daugherty in Warren County, Kentucky to find out when he arrived in the county.

Daugherty Marriages in Warren County, Kentucky

To locate Robert's children, every Daugherty marriage in Warren County, Kentucky from 1800-1840 was located. Some of the Daugherty marriages were the children of Robert's brother, Daniel Daugherty, identified using the *FamilySearch* Family Tree and correlated with other evidence.

Before beginning this project, Mary and Peter were known, through direct evidence, to be children of Robert Daugherty. By correlating census records and marriage records with estate records of Robert Daugherty and Peter Daugherty, three additional children of Robert Daugherty were identified. Two of them were married before the 1810 census, daughters Sina and Betsey.

Sina Daugherty

A bond on 24 February 1808 of John Beasly and Robert Daugherty in Warren County, Kentucky shows John Beasly's intent to marry Sina Daugherty.²³ The Robert Daugherty who signed the bond was likely the father of Sina. The county marriage register states that "Syna Daugherty and John Beasly" were married by "Doherty" on 2 February 1808. ²⁴ Robert Daugherty was authorized to perform marriages in Warren County, Kentucky

beginning in 1803.²⁵ Not only did Robert act as bondsman for his future son-in-law, but he performed the marriage.

The difference in dates on the bond and in the marriage register is probably due to a copying error. The register was a copy of Robert Daugherty's return of marriages. The marriage bond is an original record and was not recopied. Therefore the date of 24 February 1808 is probably more accurate. It's doubtful that the couple married before the marriage bond date. Typically the marriage date was 1-5 days after the marriage bond date in Warren County at this time.²⁶

Kentucky law required that fathers give consent on the marriage license and bond if their child was not yet 21 years of age.²⁷ Robert's consent was not mentioned on the bond, so Sina was probably over 21 years of age in 1808. This means she was probably born before 1787. If so, she could have been the oldest daughter in Robert's household on the 1790 census.²⁸

More research could be done to find John Beasly and Sina on the 1820 census. Sina probably died before 10 March 1823 when John Beasly married Polly Burden in Butler County, Kentucky.²⁹

Elizabeth "Betsy" Daugherty

[Elizabeth] Betsy Daugherty married Philip Romans on 14 September 1808, as recorded in the county marriage book.³⁰ The marriage was solemnized by "Robart daughety."³¹ The day before, Phillip signed a bond that he was above age 21 and Robert Daugherty, the father of his intended wife, gave his consent.³² This

means that Betsy was under age 21 and therefore born after 1787. The two females in Robert Daugherty's 1790 household were likely his wife and their daughter Sina, so Betsy probably was not born until after 1790.³³

Phillip Romans died before 26 Oct 1835 when Elizabeth Romans, "the widow of Phillip Romans," married John D. Miller.³⁴ Wm G. Romans was one of the witnesses of the marriage bond. An estate for Phillip Romans was administered in 1822, but it's uncertain whether this was the estate of Phillip Romans or his father, Phillip Romans Sr.³⁵ A household for Elizabeth Romans was found on the 1830 census, so it's likely that Phillip, her husband, died before 1830.³⁶ Additional research could show if the ages of her children match up with what is known about her children from compiled research in online family trees.

If Betsy's husband, Phillp Romans, died before 1830, who was the Philip C. Romans on the appraisement bill in Robert Daugherty's estate file in 1843? The list of property was valued by three men on 8 November 1843 who all signed their names: Solomon Neighbours, He[dgekoock?] Mcginnis, and Philip C. Romans, with Peter Daughety as administrator.³⁷

Philip C. Romans could have been a son of Philip Romans and Elizabeth "Betsy" Daugherty. An 1850 census record for Philip C. Romans shows that he lived in Warren County, Kentucky in the household of G.H. Waddell, was born in about 1813 in Kentucky and his occupation was tanner. This birth date occurs after the marriage of Phillip Romans and Betsy Daugherty in 1808. The 1830 household of Elizabeth Romans includes 2 males ages 15-19, so one of them could be this Philip C. Romans. More research on Philip C. Romans could be done to determine if he was the son of Philip and Betsy.

Elizabeth's second husband, John D. Miller, was the father-in-law of her son William G. Romans, who had married Mahala Miller in 1835.³⁹ John D. Miller died before 28 October 1855 when Elizabeth Miller, age 63, married her third husband, Hartwell Hayes, in the home of Mr. Romans in Jasper County, Iowa.⁴⁰ Elizabeth

Hays, age 69, appeared in the 1860 census in the household of Wm G. Romans in Jasper County, Iowa.⁴¹ These reported ages give a range of 1791-1792 for the birth of Elizabeth Daugherty. In 1808, when Elizabeth "Betsy" Daugherty married Phillip Romans, she would have been about 16-17 years old, consistent with needing her father to give consent to her marriage.

1810 Census

By 1810, Sina and Betsy had married and left the home of their father. In Robert Daugherty's 1810 household, there were two daughters and one son still at home. These children were probably Peter, Mary, and another daughter. Robert's household is shown in the table below.⁴²

- Robert was probably the male over 45, born before 1765.
- Sarah was probably the female over 45, born before 1765.
- Peter was probably the male age 10-16, born 1795-1800, which fits with his estimate in the 1850 census of 1799.⁴³
- Mary was probably the female age 16-25, born 1785-1794. She was not on the 1790 census, so her birth year range can be narrowed to 1790-1794.⁴⁴
- Another daughter was probably the female age 0-10, born 1800-1810.

In 1810, Daniel Daugherty lived in Warren County, Kentucky as well. His household included two adults age 26-44.⁴⁵ His neighbors included James Doughty, Jeremiah Doughty, and Preston Doughty. Marriages found in Warren County Kentucky that seem to belong to Daniel Daugherty's children include:

 Mary Daughety married Harris Evans on 7 February 1807; and on the same day, Betsey Daughety and Benjamin Gilstrap were married; the marriages were performed by "Robart daughtety"


- Preston Daughty signed a bond 10 Oct 1809 with intent to marry Nancy Wright⁴⁷
- Jeremiah Doughty and Daniel Doughty signed a bond on 23 Aug 1811 for the intended marriage between Jeremiah and Susannah Stovall⁴⁸
- John Daughety married Betsy Beasly on 23 February 1815; marriage performed by J. Taylor⁴⁹
- William Daugherty married Elizabeth miller on 2 Nov 1826; marriage solemnized by Z. Morris⁵⁰

More research should be done to find if these records belong to the children of Daniel Daugherty.

Mary's Marriage to Jacob Romans

One year after the 1810 census, Mary was married and left Robert Daugherty's home. As was previously known prior to this research project, Robert Doherty gave consent for his daughter, Mary Doherty, to marry Jacob Romans in a bond on 23 September 1811 in Warren County, Kentucky.⁵¹

Because Mary's father was required to give his consent, Mary must not have been 21 years old or older, and was therefore born after 1790.⁵² The marriage was performed by Robert, who signed his list of returns "Robart daughety, as shown below."⁵³ The marriage was recorded in the county marriage register.⁵⁴

Mary's husband, Jacob Romans, was probably a brother to Phillip Romans, both sons of Phillip Romans Sr.⁵⁵ Jacob and Mary Romans were found on the 1850 census in Butler County, Kentucky. Mary was 54 years old, born in North Carolina around 1796, consistent with needing her father's consent to marry in 1811.⁵⁶ The birthplace of Mary in North Carolina also matches the deeds that show Robert Daugherty didn't leave Craven County, North Carolina until after 1796. More research could be done to locate Mary and Jacob Romans on the 1820-1840 censuses.

1820 Census

In 1820, Robert lived in Warren County in a household of two adults over 45 and one female age 10-15.⁵⁷ His neighbors included Benjamin Sublett, Moses Taylor, James Taylor, William Taylor, James Romans, Peter Romans, Philip Romans Senr., Jacob Romans, and Ebenezer Cole.

- Robert Doharty, over 45 years, born before 1775
- Sarah, over 45, born before 1775
- Female age 10-16, born 1805-1810

The female age 10-16 probably the same daughter who was age 0-10 on the 1810 census (born 1800-1810).⁵⁸ Her age on the 1820 census from 10-15 narrows her birth year range to 1805-1810.

Peter Daugherty was no longer living at home in 1820 and was found as the head of his own household, with no other household members, age 16-25 (born 1795-1804).⁵⁹ This birth year range is consistent with the two other census records he has been found on:

- 1810, age 10-16, born 1795-1800⁶⁰
- 1850, age 51, born 1799⁶¹

Daniel Daugherty lived in Warren County, Kentucky in 1820.⁶² His household included one male and one female over age 45, and one adult male slave.

1830 Census

In the 1830 census, Robert Daugherty lived in Warren County with two women and a young boy.⁶³

The makeup of the household was probably as follows:

- Robert, male age 60-69, born 1761-1770
- Sarah, female age 70-79, born 1751-1760
- Woman, female age 20-29, born 1801-1810, daughter?
- Boy, age 5-10, born 1821-1825, son? grandson?

If Sarah (Taylor) Daugherty was 60, the youngest in her range, and the boy was 5, the youngest in his age range, she would have been age 55 when the boy was born. It is not likely that she was the mother of the boy in the household. It's more likely he was a ward or grandson. Maybe he was the son of the younger woman, age 20-29.

Another record of Robert Daugherty's household was found in the 1830 census returns for Warren County, a few pages later on p. 94.⁶⁴ The household makeup was almost the same, the only difference being the older female was age 60-69 instead of 70-79. Perhaps Robert owned two homes and was counted twice. No other records for men named Robert Daugherty have been found in this county so it's unlikely there were two men of the same name. The record on page 89 for Robert Daugherty includes no neighbors that are recognized relatives or known associates. The entry on page 94 includes many neighbors who were relatives or

associates to Robert, including Moses Taylor Jr., James Taylor, Emily Taylor, Benj. Mcginnis, James Romans, and Moses Taylor Sr. Robert's brother Daniel Daugherty lived in Butler County, Kentucky in 1830.⁶⁵

Marriage of Anna Daugherty to John Manning

On 23 January 1840, John Manning signed a bond indicating that he intended to marry Anna Dougherty, with bondsman Atwood G. Hobson.⁶⁶ Anna was probably the youngest daughter of Robert and Sarah Daugherty who resided with them in 1810, 1820, and 1830. Robert Daugherty did not perform the marriage. He may have been retired. The rites of matrimony were performed by William Sublett on 30 January 1840.⁶⁷

Anna and John Manning were found on the 1850 census in Warren County, Kentucky Anna was 45 years old and born in Kentucky. ⁶⁸ She was born about 1805, which matches previous census years as a female in Robert Daugherty's households. She died 18 June 1880 and was buried in the Romans-Spencer Graveyard. ⁶⁹

Two clues give additional evidence that Anna was the daughter of Robert Daugherty.

- John Manning purchased an item from the estate of Robert Daugherty, deceased.
- John Manning was a surety on the estate administration of Peter Daugherty in 1860, as discussed later.⁷¹

1840 Census

In Robert's 1840 household, he was living with an old woman and a young enslaved female.⁷² His youngest daughter, Anna left the household earlier in the year when she married John Manning. The young boy from the

1820 census was not with the family anymore. More research could be done to find Anna (Daugherty) Manning in 1840 and later censuses to see if the boy went with her.

Peter Daugherty Never Married

Peter Daugherty probably never married. In 1820, Peter lived alone in Warren County, Kentucky.⁷³ In 1830 he lived in Warren County, Kentucky with two other people:⁷⁴

- o male age 15-19
- o male age 20-29 (probably Peter, born 1801-1810)
- o female enslaved person 10-23

In 1840, Peter was not found on the census.⁷⁵ In 1850, Peter was age 51, born 1799 in Kentucky, a farmer, and lived near Andrew J. Daugherty.⁷⁶ More research could be done to determine how they might be related. Peter's 1850 household included:

- Mary Smull, age 40, born in Kentucky
- Charles Crabb, age 24, born in Kentucky, occupation farmer

Peter was found on the 1850 Slave Schedule owning 9 slaves:77

- o Female, age 42
- o Male, age 21
- o Male, age 18
- o Male, age 14

- o Male, age 12
- o Female, age 10
- Male, age 10
- o Male, age 7
- Male, age 6

In 1860, Peter was age 65, (born 1795), with the birthplace of Kentucky. He lived with no other free white people. His real estate value 4,000 and personal estate value 7,000.⁷⁸ According to the 1860 Slave Schedule, he owned 6 slaves:⁷⁹

- o Female, age 50
- o Male, age 30
- o Male, age 27
- o Male, age 24
- o Male, age 20
- o Female, age 16

Peter's estate administration on 8 October 1860 revealed that he died intestate. R.F. Romans was appointed administrator with John S. Burden, John Maning [sic], and Wiley R. Beasley sureties.⁸⁰

Future research could explore R.F. Romans, John S. Burden, John Manning, and Wiley R. Beasley. John Manning could be the same man as Anna Daugherty's husband. R.F. Romans could be a son of Peter's sisters - either Betsy and Philip Romans or Mary and Jacob Romans. John S. Burden could be related to Peter's brother-in-law, John Beasley's second wife, Polly Burden. John Manning is likely Peter's sister, Anna Daugherty's husband. Wiley R. Beasley could be a descendant of Sina and John Beasley.

An oral tradition was passed down by Daugherty families in Butler county, Kentucky that Peter Daugherty "had a son by his slave woman." The 1850 and 1860 slave schedules show that this could be a possibility. Peter could have had a relationship with the 10-23 year old woman he owned in 1830. She may be the same woman as the 42-year-old enslaved woman in 1850 and 50-year-old enslaved woman in 1860. The other enslaved people could be their children. Some of the ages of the enslaved children match up from 1850 to 1860.

Additional research into the deeds of Peter Daugherty in Butler County, Kentucky, could shed more light onto any purchases or sales of enslaved people that Peter was party to. Additional research in the 1870 census of Butler County, Kentucky could show the names of the enslaved people Peter Daugherty owned. The estate file of Peter Daugherty could also show their names. DNA evidence could shed light on this mystery as well.

Conclusion

Robert Daugherty and Sarah Taylor had at least five children: Sina, Elizabeth, Peter, Elizabeth, and Anna, as shown in the genealogical summary below. The spacing of the children's births could indicate that they had other children who did not survive to adulthood. The missing 1800 Kentucky census leaves a gap in the records that could show if they had other children in their young married years. More research on the children identified in this report could locate the grandchildren of Robert and Sarah.

Genealogical Summary

Robert Daugherty was born about 1761-1770, probably in Craven County, North Carolina. He died before 23 October 1843 Warren County, Kentucky. He married **Sarah Taylor** on 18 November 1784 in Craven County, North Carolina. Sarah was born about 1751-1760, probably in Craven County, Kentucky, daughter of Moses B. Taylor and Elizabeth Prevatte. She died after 1843, probably in Warren County, Kentucky.

Known children of Robert Daugherty and Sarah Taylor were as follows:

- SINA DAUGHERTY was born bef. 1787 probably in Craven County, North Carolina. She married John Beasly on 24 Feb 1808 in Warren County. 84 She died before 10 Mar 1823. 85
- ii. ELIZABETH "BETSY" DAUGHERTY was born about 1791-2. She married (1) Phillip Romans on 15 September 1808 in Warren County, (2) John D. Miller on 26 October 1835 in Butler County, and (3) Hartwell Hayes on 28 October 1855 in Jasper County, Iowa. The died after 1860.
- iii. PETER DAUGHERTY was born about 1799 in Kentucky.⁸⁹ He died before 10 Oct 1860.⁹⁰
- iv. MARY DAUGHERTY was born about 1796 in North Carolina. ⁹¹ She married Jacob Romans on 23 September 1811 in Warren County. ⁹² She died after 1850. ⁹³
- v. ANNA DAUGHERTY was born about 1805 in Kentucky.⁹⁴ She married John Manning on 30 January 1840 in Warren County.⁹⁵ She died 18 June 1880 and was buried at the Romans-Spencer Graveyard in Warren County.⁹⁶

Future Research

- Find additional records for Robert Daugherty in Warren County and Butler County, Kentucky
 - Land records starting in 1797
 - Tax records starting 1797-98
 - Tax records after Robert's death in 1843 to see if Sarah is listed
- Find John Beasly (and wife Sina) on the 1820 census
- Correlate the people in Elizabeth Romans 1830 Butler County, Kentucky household with online family trees to see if this matches her known children. If yes, this adds evidence that her husband, Philip Romans died before 1830.
- Find Mary (Daugherty) Romans in census records with her husband beginning in 1820.
- Philip C. Romans listed on the list of property appraised for Robert Daugherty's estate in 1843 could be the son of Philip Romans and Betsy Daugherty, born about 1813. Research his parentage.
- Find Peter Daugherty in 1840 census
- Find Anna (Daugherty) Manning in 1840 and later censuses to see if the unidentified boy in the 1830 census went with her after she married John Manning.
- Trace Andrew J. Daugherty, 1850 census neighbor to Peter Daugherty, to find if they are related
- Find R.F. Romans, John S. Burden, John Manning, and Wiley R. Beasley in Warren County, Kentucky records to determine their relationship to Robert Daugherty's descendants.
- Search deeds of Peter Daugherty in Butler County, Kentucky
- Search the 1870 census of Butler County, Kentucky for Daughertys who could be the freed slaves of Peter Daugherty
- Search for the estate file of Peter Daugherty to find the names of the enslaved people he owned
